

## OFFICE OF FINANCE & BUSINESS SERVICES CHARTFIELD COMBINATION REQUIREMENTS

### Defining Chartfields

The College of New Jersey has adopted the following Peoplesoft chartfields: Fund, Class, DeptID, Program, Account, and Project Grant. A Chartfield combination is a group of chartfields that are representative of a cost center (i.e. departments, program, grant). Class, Fund, and Account, are required chartfields for all college activity. DeptID is valid for general college operating activity. Programs are valid for activities outside of general college operations. Project/Grants are chartfields specifically used for construction projects and restricted Grants and Contracts.

### Determining which chartfield combinations are appropriate.

#### Fund (2 characters)

- Fund codes are assigned based upon the funding source. The fund code is primarily used for financial statement reporting.

#### Class (2 characters)

- Class codes are assigned to classify various expenses for State reporting purposes.

#### DeptID (4 Characters)

- In general, represents operating activity related to the different departments within the college.

#### Program (5 Characters)

- Represents a cost center activity within a department, one that crosses multiple departments, or operates independently. For example, self-funding accounts have been assigned program codes in Peoplesoft.

#### Project/Grant (5 characters)

- Only restricted grants and capital projects warrant a project/grant number. Examples of project/grants are research grants, financial aid grants and major construction projects.

#### Account (5 characters)

- The account designates the type of transactions such as revenues and expenses.
